We are grieved to have learned that the General Conference of Seventh-day Adventists has persisted in bringing lawsuits against those of the same faith who are not a part of their church organization when they call themselves Seventh-day Adventists or use the Adventist name. Although they lost the Kinship case, which resulted in allowing homosexuals to call themselves Seventh-day Adventists, the pastor of the Creation Seventh-day Adventist Church told

"Eyewitness News" on his local news channel in April, 2012, that he is ready to give up the pulpit for prison because his church has been ordered to quit using Seventh-day Adventist in its name. He said, "We would really like to comply to the court orders. We respect the courts; we respect the law. But in this case the law is violating our conscience and we must put our conscience before the law." While we may not completely agree with others beliefs and methods, we wholeheartedly support each individual's right to exercise religious liberty.

On April 15 the pastor wrote an open letter in which he stated, "...I am willing to be incarcerated for my faith... Since the courts have ruled my religion is illegal, and I cannot in good conscience give up the name of my faith. I am repeatedly in contempt of court.

Concerning initiating a legal battle or any other battle against commandment keepers, Ellen White had the following to say: "It is not the true church of God that makes war with those who keep the commandments of God and have the testimony of Jesus Christ." Signs of the Times, April 22, 1889.

Concerning those who do this she also wrote, "They show that they have chosen the world as their judge, and in heaven their names are registered as one with unbelievers. Christ is crucified afresh, and put to open shame. Let these men know that God does not hear their prayers. They insult His holy name, and He will leave them to the buffetings of Satan until they shall see their folly and seek the Lord by confession of their sin." Selected Messages, vol. 3, 299.

"Jesus did not appeal to the law for redress when He was unjustly accused. When He was reviled, He reviled not again; when He was threatened, He did not retaliate. ... I have written largely in regard to Christians who believe the truth placing their cases in courts of law to obtain redress. In doing this, they are biting and devouring one another in every sense of the word, 'to be consumed one of another.' They cast aside the inspired counsel God has given, and in the face of the message He gives they do the very thing He has told them not to do. Such men may as well stop praying to God, for He will not hear their prayers. They insult Jehovah, and He will leave them to become the subjects of Satan until they shall see

their folly and seek the Lord by confession of their sins." Ibid., 302.

"This action, of appealing to human courts, never before entered into by Seventh-day Adventists, has now been done. God has permitted this that you who have been deceived may understand what power is controlling

power is controlling those who have had entrusted to them great responsibilities." Ibid., 303.
